**WELLNESS PLAN AGREEMENT**

This agreement is entered into between Mitchell Animal Hospital hereinafter referred to as the "Veterinary Practice", and "**Client Name**", hereinafter referred to as the "Client".

**1) Services to be Provided**

During the Term the Veterinary Practice hereby agrees to provide to the Client for the companion animal identified below the bundle of services and related costs listed on Schedule "A" attached (the "Services").

**2) Fee**

The Client hereby agrees to pay for the Services a fee of \$ \_\_ each month during the Term. Such payment shall be processed on the \_\_ th of each month using the method of payment agreed to between the Veterinary Practice and the Client.

**3) Term**

- (a) Unless otherwise terminated as provided for herein, the term of this agreement is for 12 months and expires on \_\_ (the "Term").
- (b) At the end of the Term, unless this agreement has been terminated as provided in Section 4 below, this agreement shall automatically renew for a further 12 months, and the Term shall be extended accordingly. The Veterinary Practice shall provide a reminder notice to the Client prior to the end of a Term advising the Client of the automatic renewal.
- (c) If the Services to be provided under this agreement are to be amended, or the fee for the Services is to be changed for a renewal Term, the Client will be asked to execute an amended agreement prior to the end of the term, which specifies the amended Services and / or fee.

**4) Termination**

- (a) The Client may terminate this agreement at any time on thirty (30) days written notice to the Veterinary Practice. Notice by email shall constitute proper notice. If this agreement is terminated by the Client prior to the end of the Term, the Client shall be required to pay to the Veterinary Practice an amount equal to the lesser of the following two amounts: first, the remaining payments under the agreement during the Term; and second, the total value of the Services rendered

and discounts received under the agreement, less the actual amounts paid by the Client for Services to the date of termination.

- (b) In the event that the Veterinary Practice is unable to provide the Services for any reason, the Veterinary Practice may terminate this agreement by providing written notice to the Client. Notice by email shall constitute proper notice. The Veterinary Practice shall refund to the Client the difference between the amount paid to the date of termination and the total value of the Services rendered and discounts received under the agreement to the date of termination.
- (c) The Veterinary Practice may terminate this agreement if the Client is in default of payment of the fee and such default continues for more than thirty (30) days. If this agreement is terminated by the Veterinary Practice for default, the Client shall be required to pay to the Veterinary Practice an amount equal to the lesser of the following two amounts: firstly, the remaining payments under this agreement during the Term (including overdue payments); and secondly, the total value of the Services rendered and discounts received under this agreement, less the actual amount paid by the Client for Services to the date of termination.

For the purposes of Section 4 (a), (b) and (c) above, the value of the Services rendered and discounts received shall be determined using the Veterinary Practice's current fee schedule and product pricing.
